

## Endowment Matching Grant Application for Year 2017

***The Endowment Committee of Mt. Auburn United Methodist Church is pleased to announce the availability of grants from the Undesignated Endowment Fund for usage by award grantees by June 30, 2018.***

### **Grant Application Information:**

1. The amount of available funds to be awarded will be set in early 2017 and will be awarded by September 30, 2017.
2. The applicant will agree to match the amount of the grant with funding from sources other than Mt. Auburn Budgeted Ministries. Funds used to match this grant may be from Designated Funds of Mt. Auburn that have been received in support of this applicant's goal, from personal funds, or from other organization sources, or fundraising within Mt. Auburn if approval has been received from Mt. Auburn.
3. The applicant must be
  - a) A congregation member or constituent member of Mt. Auburn,
  - b) A leader or member of a sponsored group of Mt. Auburn,
  - c) A staff member or clergy of Mt. Auburn.

The applicant may be a designated representative of a group such as a church department, committee or mission group, a scout troop, children's, youth or a life group.

4. All applications must be for the purpose of funding a charitable ministry purchase or event that is not generally funded through the budget process of Mt. Auburn United Methodist Church. Additionally, all applications must meet the criteria of Mt. Auburn United Methodist Church's Mission and Vision Statement (see below).

6. All applicants will be informed in writing whether or not their request has been granted by September 30, 2017. Upon award, grantees will be given information on fund disbursement and reporting requirements.
7. Reporting requirements should include a brief written report with pictures if available and also to be available to share your experience at the annual Endowment recognition event.
